THE FACTS

- Lactoferrin is a naturally occurring substance found in all body fluids including tears, blood and saliva. Lactoferrin is a basic building block of life. It is an essential protein and a major component of mother's milk, and in this way is provided to all mammals beginning immediately after birth.
- Lactoferrin is provided in a normal diet through dairy foods. Yet some of us do not receive a significant amount of lactoferrin in this form.
- The exclusive, patented technology that produces LF Gold 1.8® uses exhaustive purification methods to remove microorganisms and endotoxin compounds. This provides an unprecedented level of purity while also preserving the prebiotic qualities of the lactoferrin.
- LF Gold 1.8 has been reformulated from the original, with natural lecithin (derived from sunflowers) replacing Polysorbate 80 as a stabilizer. This is an improved, more natural formulation yet it retains the same degree of bioavailability.
- · Natural sodium citrate and bicarbonate have also been added, to balance pH. The new formulation doubles the amount of vitamin C, to enhance the antioxidant potential and help support the body's resistance to cellular damage. A new, larger capsule accommodates these improvements and provides greater ease in administration.
- This precision technology requires approximately three litres of milk to produce a single capsule of LF Gold 1.8°.
- The source of LF Gold 1.8° is natural milk from a region isolated from sources of contamination. This source material is then subjected to extensive purification technology to produce LF Gold 1.8.
- LF Gold 1.8® is referred to as highly functional lactoferrin because its unique production technology results in a form of lactoferrin that is more accessible for the body to absorb. This technology removes contaminants that could inhibit lactoferrin absorption or metabolism.
